## **1. Executive Summary**

## 2. Introduction

Problem Statement: Clearly define the specific problem your project will address.

## 3. Objectives

List the primary and secondary objectives of your project. Objectives should be SMART: Specific, Measurable, Achievable, Relevant, and Time-bound.

## 4. Methodology

Describe the methods and approaches you will use to achieve your project objectives. This section varies significantly depending on the project type:



- **Research Proposal:** Outline your research design, data collection, and analysis methods.
- **Policy Analysis:** Explain how you will review current policies, identify gaps, and propose modifications.
- **Policy Advocacy Initiative:** Detail your campaign strategy, including key messages, target audiences, and communication channels.

#### 5. Expected Impact

**Outcomes and impact:** Describe the direct results you anticipate from your project and how it will contribute to the elimination of the targeted disease(s) in the long term.
